

Announcement of Skills Test under the EPS

The 1st Skills Test in Sri Lanka for manufacturing industry under EPS is to be conducted for those who have passed the EPS-TOPIK. Any person who wishes to take the test shall apply for the test as follows.

1. Industry category for test application : Manufacturing

2. Qualification

A. **Any persons who scored 172points or more(full mark: 200point) in 8th EPS-TOPIK(Result was announced on Nov 18,2010)**

B. **Any persons who scored 172points or more(full mark: 200point) in 9th EPS-TOPIK(Result was announced on Oct 28,2011)**

※ Those who have entered Korea, those who have abandoned job application (immigration), and those who are not permitted to get the Certificate for Confirmation of Visa Issuance (CCVI) are excluded from the possibility of registration.

3. Registration

A. Registration period: November 1~3, 2011(for 3 days)

※ **Registration hours: 09:00~18:00(lunch time : 12:00~13:00)**

B. Registration place: **SLBFE Office**

C. Registration method: Individual visit registration or phone registration

D. Required documents: ID Card or EPS-TOPIK Admission Ticket

E. **Test fee: Free**

4. Announcement of test date/time, test venue for each applicant

- A. Announcement date: Nov 23, 2011

- C. (Expected) test date: During Dec 3~9, 2011(the date can be subject to change)

5. Announcement of Test Result

- A. **Date : December 20, 2011 (Tue)**
- B. **Method**
 - Access to the EPS Website(<http://www.eps.go.kr>), click “multi language version”
 - Sign up
 - Check the test result individually

6. Special Benefit for High Scorer and attendee

- A. Those with excellent scores will have priority in terms of primary job recommendation to Korean employers (for three times)
- B. Attendee for the skills test will have priority in terms of Secondary job recommendation to Korean employers (for three times)
- C. Requirement for excellent scores: earn more than 240 points in total, and scored more than 40 points in all areas.

7. Skills Test method and details

- A. **Contents of the Skills Test and allocated points**
 - The Skills Test is comprised of three areas including physical test, evaluating job experience and interview, and basic skill test.

8. Task Contents of Physical Test

Test items	Details	Remarks
Basic movement	High jump with arms open : 5 consecutive times	
Endurance	measuring the consecutive number of dips(1min)	

Grasping power	Measure hand grasping power only once per each hand using a measuring instrument (in kilograms)
flexibility	Measure upper body bending sitting on a measuring instrument. (in centimeters)
Back muscle strength	Measure back muscle strength only once using a measuring instrument (in kilograms)

9. Task Contents of the Interview Assessment

Evaluation items	Evaluation details	Remarks
Basic communication	Basic Communication skills in Korean	Interview will be filmed (for 30 seconds) and provided to Korean employers.
Reading sentences	Reading Four or five sentences in Korean	
Understanding orders	understanding basic orders in Korean	
Job experience	Job experience and period of employment	
Personality & Ability	Attitude, positiveness, preparedness etc.	

10. Contents of Basic skill test

Evaluation items	Evaluation details	Remarks
Answer the name of the equipment	Speaking about the name of the equipment (3questions), Listening and finding(3 questions)	
Put sticks on the board	Put the different sticks on the board (various color, shape, size sticks)	
Handling and hanging up materials	Hanging up the rings of the different size in the correct position	
Loading materials	Put together the pieces of the work model on the board	

11. Instructions for Applicants

- A. Test date and venue for each applicant will be announced on Nov 23, 2011 (Wed) and please refer to the announcement on the date.
- B. You cannot change the designated test date and venue and no one is allowed to enter the venue after the designated entry time. No admittance to anyone

arrives after the designated entry time.

- C. No admittance to anyone did not bring their ID card(Passport)and admission ticket
- D. The tools and equipment for the test will be prepared at the venue, so it is not required for applicant to bring any tools or equipment (except for an ID card and an admission ticket).
- E. We advice you to pay special attention to your safety during the test. You are entirely responsible for any accidents caused by your negligence.
- F. It is recommended to wear comfortable and neat clothes that cause no inconvenience in the skills test.
- G. You will get zero point in case of cheating during the test.
- H. Please check the contents of the Task Instructions, announced with this, and prepare to get good result from the test.
- I. All passers of EPS-TOPIK can apply for a job regardless of their skills test result, and the video, filmed during the test, will be provided to Korean employers as a reference.
